

## Training Course on Conceptual Models for Water Resource Management Using Isotope Hydrology and Hydrochemistry: Part 1

### Introduction

The course is open to 15 to 20 participants. In the selection of nominated participants priority will be given to technical and scientific staff involved in planning and implementing hydro(geo)logical research and/or projects related to water resources assessment and management involving the use of isotope hydrology tools and approaches.

## **Objectives**

The training course will comprise lectures and case studies covering theoretical concepts on hydrogeology (geology and groundwater hydraulics), geography and geomorphology, conceptualization of GIS and remote sensing information, surface water / groundwater interactions, impacts of water-rock interactions on water quality interpretation, and how Isotope Hydrology can be used to refine and focus the conceptual (and ultimate mathematical modelling) of Water Resources for conjunctive management decision making.

## **Target Audience**

Participants should have a university degree with a technical/scientific profile that attests to their experience with the use of hydrological, hydrogeological or hydrochemical techniques, and/or their involvement in water resources assessment and/or management. They should preferably have a good understanding of water related/hydrogeological issues. As the course will be conducted in English, participants should have sufficient proficiency to follow lectures and express themselves in this language without difficulty. In the case of countries in which English is not an official or customary language, nominations must be accompanied by a separate certificate attesting to the candidate's proficiency in English. This certificate must be issued by a language school or cultural institution, or by the embassy of a country in which English is spoken.

## **Participation and Registration**

All persons wishing to participate in the event have to be designated by an IAEA Member State or should be members of organizations that have been invited to attend.

  - Complete or update their personal details under 'Complete Profile' and upload the relevant supporting documents.
  - Search for the relevant event under the 'My Eligible Events' tab.
  - Select the Member State or invited organization they want to represent from the drop-down menu entitled 'Designating Authority' (if an invited organization is not listed, please contact <a href="mailto:InTouchPlus.Contact-Point@iaea.org">InTouchPlus.Contact-Point@iaea.org</a>).
  - If applicable, indicate whether financial support is requested and complete the relevant information (this is not applicable to participants from invited organizations).
  - Based on the data input, the InTouch+ platform will automatically generate the Participation Form (Form A) and/or the Grant Application Form (Form C).
  - Submit their application.

Once submitted through the InTouch+ platform, the application, together with the auto-generated form(s), will be transmitted automatically to the required authority for approval. If approved, the application, together with the applicable form(s), will automatically be sent to the IAEA through the online platform.
